ORDINANCE NO. 164

“Motor Vehicles Ordinance”

AN ORDINANCE AMENDING THE EAST COVENTRY TOWNSHIP CODE OF ORDINANCES, CHAPTER 15 (MOTOR VEHICLES), PART 2 (TRAFFIC REGULATIONS), SECTION 201 (MAXIMUM SPEED LIMITS ESTABLISHED ON CERTAIN STREETS) TO ESTABLISH A MAXIMUM SPEED LIMIT OF 25 M.P.H FOR THE ENTIRE LENGTH OF DEDICATED ROAD ON BAYBERRY LANE AND NORTH SAVANNA DRIVE, AND FOR THE ENTIRE LENGTH OF LUBOLD ROAD AND SAGE DRIVE; TO AMEND SECTION 209 (STOP INTERSECTIONS ESTABLISHED) TO DESIGNATE THE INTERSECTIONS OF BAYBERRY LANE AND LUBOLD ROAD, LUBOLD ROAD AND ELLIS WOODS ROAD, AND NORTH SAVANNA DRIVE AND LUBOLD ROAD AS 1-WAY STOP INTERSECTIONS; AND TO AMEND PART IV (GENERAL PARKING REGULATIONS), SECTION 402 (PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS) TO PROHIBIT PARKING ON BOTH SIDES OF AND FOR THE ENTIRE LENGTH OF DEDICATED ROAD ON BAYBERRY LANE AND NORTH SAVANNA DRIVE, AND FOR THE ENTIRE LENGTH OF LUBOLD ROAD AND SAGE DRIVE.

The Board of Supervisors of East Coventry Township does hereby **ENACT** and **ORDAIN:**

SECTION I. - Amendment to Code

The East Coventry Township Code of Ordinances, Chapter 15 (Motor Vehicles), Part 2 (Traffic Regulations), Section 201 (Maximum Speed Limits Established on Certain Streets) is hereby amended to establish the following speed limits:

§201. Maximum Speed Limits Established on Certain Streets.

1. Maximum speed limits are established on portions of specified streets, as follows, and it shall be unlawful for any person to drive a vehicle, on any part of a street where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street:

<u>Street</u>	<u>Between</u>	<u>Maximum Speed Limit</u>
Bayberry Lane	Entire length of Dedicated Road	25 m.p.h.
Lubold Road	Entire length	25 m.p.h.
North Savanna Drive	Entire length of Dedicated Road	25 m.p.h.
Sage Drive	Entire length	25 m.p.h.

SECTION II. – Amendment to Code

The East Coventry Township Code of Ordinances, Chapter 15 (Motor Vehicles), Part 2 (Traffic Regulations), Section 209 (Stop Intersections Established) is hereby amended to designate the following intersections as 1-Way Stop Intersections:

§209. Stop Intersections Established.

1. The following intersections (in addition to intersections with the through highways established by §209) are established as stop intersections, and official stop signs shall be erected (or are ratified if previously erected) in such a position as to face traffic in the direction or directions indicated for that intersection. Every driver of a vehicle approaching the intersection in the direction indicated in each case, shall stop the vehicle as required by Section 3323(b) of the Vehicle Code, and shall not proceed into or across the intersecting or through street until he has followed all applicable requirements of that section of the law.

A.. 1-Way Stop Intersections

North Savanna Drive	West	Lubold Road	

SECTION III. – Amendment to Code

The East Coventry Township Code of Ordinances, Chapter 15 (Motor Vehicles), Part 4 (General Parking Regulation), Section 402 (Parking Prohibited at all Times in Certain Locations) is hereby amended to prohibit parking at the following locations:

§402. Parking Prohibited at all Times in Certain Locations.

Parking shall be prohibited at all times in the following locations:

<u>Street</u>	<u>Side</u>	<u>Between</u>
Bayberry Lane	Both	Entire Length of Dedicated Road
Lubold Road	Both	Entire length
North Savanna Drive	Both	Entire length of Dedicated Road
Sage Drive	Both	Entire length

SECTION IV. - Severability

The provisions of this Ordinance are intended to be severable, and if any section, sentence, clause, part or provision hereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Board that this Ordinance would have been adopted even if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

SECTION V. - Failure to Enforce not a Waiver

The failure of the Township to enforce any provision of this Ordinance shall not constitute a waiver by the Township of its rights of future enforcement hereunder.

SECTION VI. - Effective Date

This Ordinance shall take effect and be in force from and after its approval as required by the law.

SECTION VII. - Repealer

All other ordinances and resolutions or parts thereof insofar as they are inconsistent with this Ordinance are hereby repealed.

NOTICE

NOTICE is hereby given that the Board of Supervisors of East Coventry, at its public meeting on March 8, 2010 in the Township Building, 855 Ellis Woods Road, Pottstown, Pennsylvania, will hold a public hearing on and could vote to adopt an ordinance entitled “Motor Vehicles Ordinance” amending the East Coventry Township Code of Ordinances, Chapter 15 (Motor Vehicles), Part 2 (Traffic Regulations), Section 201 (Maximum Speed Limits Established on Certain Streets) to establish a maximum speed limit of 25 m.p.h for the entire length of dedicated road on Bayberry Lane and North Savanna Drive, and for the entire length of Lubold Road and Sage Drive; to amend Section 209 (Stop Intersections Established) to designate the intersections of Bayberry Lane and Lubold Road, Lubold Road and Ellis Woods Road, and North Savanna Drive and Lubold Road as 1-Way Stop Intersections; and to Amend Part IV (General Parking Regulations), Section 402 (Parking Prohibited at All Times in Certain Locations) to prohibit parking on both sides of and for the entire length of dedicated road on Bayberry Lane and North Savanna Drive, and for the entire length of Lubold Road and Sage Drive.
